GENERAL INFORMATION

Adjutor is a unique nonionic spreader-sticker formulated to protect pesticides from premature chemical breakdown by buffering the spray solution. Additionally, Adjutor enhances surface coverage of spray solutions while providing wash-off protection from untimely rainfall. When used as directed, Adjutor will increase wetting, adhesion, and endurance of pesticide sprays on target surfaces. This is especially beneficial during windy and rainy periods, as well as under other adverse weather conditions.

SHAKE WELL BEFORE USING

DIRECTIONS FOR USE

The addition of adjuvants to some pesticides and/or fertilizers and their tank mixes may cause phytotoxicity to the foliage. Be careful to read insecticide product label carefully to determine if the product prohibits the addition of a polymer which could cause phytotoxicity. In the absence of specific recommendations, follow the guidelines set forth below.

FOR USE WITH PESTICIDES REGISTERED FOR TURF AND ORNAMENTAL AS WELL AS EXTERIOR STRUCTURAL USES. NOT FOR AQUATIC USE.

USE RATE

As a general guideline, use 0.5 ounces per gallon in a spraying system.

MIXING

In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add Adjutor. Next add the selected insecticide product. Finish filling to desired spray volume level and continue agitation.

STORAGE AND DISPOSAL

Protect product from freezing. If product freezes, warm to room temperature before use. Store in original container only and do not reuse empty container. Rinse container thoroughly and dispose of the container in accordance with local, state and federal regulations.
