PHYSICAL OR CHEMICAL HAZARDS

Contents under pressure. Do not use or store near heat or open flame. Do not puncture or incinerate container. Exposure to temperatures above 130°F may cause bursting.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Do not use in commercial food processing, preparation, food storage or serving areas. In the home, all food processing surfaces and utensils should be covered during treatment, or thoroughly washed before use. Exposed food should be covered or removed. Avoid contamination of food or feedstuffs. Remove pets and birds and cover fish aquariums before spraying.

FOR INDOOR USE ONLY: Aerothor Flea IGR + Adulticide kills fleas and ticks. It contains a unique combination of ingredients that kills adult, preadult fleas (larva) and flea eggs. Even kills fleas before they grow up to bite. NYLAR, a unique ingredient in this flea spray, continues to kill fleas for 210 days (7 months) by preventing their development into the adult biting stage. It reaches fleas hidden in carpets, rugs, drapes, upholstery, pet bedding, and floor cracks.

FLEAS & TICKS: SHAKE WELL. Hold can upright 2 or 3 feet from surfaces to be treated. Turn container upside down and point valve toward surface to be sprayed. Be sure to apply uniformly using a sweeping motion to carpets, rugs, drapes and all surfaces of upholstered furniture. Be sure to treat pet bedding, as this is a primary hiding place for fleas. No need to remove pet bedding after treatment. **DO NOT TREAT PETS.** Use a registered flea control product on your pets in conjunction with this treatment. Avoid wetting furniture and carpeting. A fine mist or spray applied uniformly is all that is necessary to kill fleas and ticks.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

3. HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW: CAUTION. Contents under pressure. DO NOT use or store near heat, sparks, open flame, or any other ignition sources. DO NOT expose to temperatures above 130°F (54°C) as bursting may occur. Harmful if absorbed through the skin. Avoid contact with skin, eyes, and clothing.

DO NOT puncture or incinerate container. DO NOT apply this product in or on electrical equipment due to the possibility of shock hazard. Follow the "Directions For Use" on the label very carefully.

POTENTIAL HEALTH EFFECTS: EYES: Causes moderate eye irritation. SKIN: Can cause skin irritation. Can cause a burning or pricking sensation on more sensitive areas (face, eyes, mouth). SKIN ABSORPTION: Harmful if absorbed through the skin. INGESTION: May be harmful if swallowed. INHALATION: Excessive inhalation of mists can cause nasal and respiratory irritation.

SIGNS AND SYMPTOMS OF EXPOSURE: CHRONIC EFFECTS: None known. This material is considered to be hazardous by the OSHA Hazard Communication Standard (29 CFR 1910.1200).

4. FIRST AID MEASURES

EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

SKIN: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

5. FIRE FIGHTING MEASURES

FLAMMABLE CLASS: This aerosol is NOT classified as FLAMMABLE by the flame extension test method described in 16 CFR 1500.45.

EXTINGUISHING MEDIA: Foam, carbon dioxide or dry chemical.

HAZARDOUS COMBUSTION PRODUCTS: Under fire conditions this product may support combustion and may decompose to give off toxic gases such as carbon monoxide, carbon dioxide, and nitrogen oxides.

EXPLOSION HAZARDS: Contents under pressure. Exposure to temperatures above 130°F (54.4°C) may cause bursting.

FIRE FIGHTING PROCEDURES: Treat as an oil fire. Use a full-faced self-contained breathing apparatus along with full protective gear. Keep nearby containers and equipment cool with a water stream.

7. HANDLING AND STORAGE
